

# TOPP's Higher Education Scholarship Application Packet

## Information and Eligibility

### Scholarship's Objective:

- To support college or trade school students with type 1 diabetes by providing financial assistance as they start their higher education.

### Details:

- Four (4) students will be given a \$500 one-time award
- Scholarships are not based on financial need
- The 2022 Scholarship application window will open March 1<sup>st</sup>, 2024 and end on June 30<sup>th</sup>, 2024
- The application must be completed by the student who is applying for the scholarship (not a parent)

### Eligibility/Requirements for TOPP's 2023 College Scholarships:

- Applicant must have Type 1 Diabetes
- Applicant must in the 2024 high school graduating class (must provide a copy of your high school diploma and/or transcript after graduation)
- Applicant must be seeking higher education at a U.S. accredited four-year university, college, technical or trade school in the United States. Applicant must provide proof of admittance
- Applicant must be an U.S. citizen or permanent resident
- Applicant must be Pennsylvania resident and live in Bucks County, Montgomery County, or Philadelphia County, PA. (Include a copy of either PA driver license or US passport)
- Applicant must complete and submit the application packet and provide all the necessary documents

### Award Notification:

- The recipients of the 2024 scholarships will be notified via email no later than July 31<sup>st</sup>, 2024. Those applicants not selected will not receive any other notification.
- Scholarship recipients are selected based on the information shared on their application. Prior to the announcement, we may contact finalists with additional questions about their application.
- The scholarship winners will be required to provide a photo of themselves that may be used on TOPP Foundation's social media accounts and website.
- The scholarship winners will be announced on TOPP Foundation's website and social media accounts.
- Before we award the scholarship, the winner will be required to confirm their academic enrollment status. Depending on the circumstances, verification of Student ID and/or their Fall schedule may be required.
- Upon verification that the winners are registered to an accredited four-year university, college, technical or trade school, the award check will be paid directly the financial aid office of the winner's academic institution to be applied to their tuition.
